OUR HISTORY:

RIDDHI SIDDHI SANSTHA was formed in 2016 with the sole aim of propagation of adult literacy in low income communities of MAN block in satara dist.. Literacy was perceived as a wherewithal to mobilise marginalised people around their own issues. RIDDHI SIDDHI SANSTHA was established primarily by upper caste, upper class, well educated, well employed people who came from outside community. Founders of RIDDHI SIDDHI SANSTHA ,RIDDHI SIDDHI SANSTHA were intellectually influenced by surekha kalel's theory of conscientization which is rooted in bringing about social change by facilitating processes in which the people from marginalised communities think critically, take ownership of bringing about the change by working together. In the last 3 years, the organization has evolved (and keeps evolving) in terms of the issues it focuses on, the scale of work, the organizational structure and the strategies adopted while retaining the core 'community led' approach in work. Some of the dimensions of RIDDHI SIDDHI SANSTHA s' evolution are:

RIDDHI SIDDHI SANSTHA is an organization that was established in 2016 with the primary goal of promoting adult literacy within low-income communities in the MAN block of Satara district. • **Child Rights Program**

Organization Name Our Riddhi Siddhi Sanstha **Overview** Our Riddhi Siddhi Sanstha is a non-profit organization dedicated to fighting against child sexual abuse and supporting victims under the POCSO (Protection of Children from Sexual Offences) Act in the district. We are committed to providing legal assistance, counseling, and support to the victims and their families, ensuring justice is served, and creating a safe environment for children.

Cases and Results Currently, we are actively working on 128 cases related to child sexual abuse under the POCSO Act. These cases involve representing the victims in court, ensuring the accused face the legal consequences of their actions, and providing necessary support throughout the legal process. So far, we have achieved positive results in 2 cases, where the accused have been convicted and sentenced to 10 years each. These successful outcomes highlight our dedication to ensuring that perpetrators of child sexual abuse are held accountable for their actions. **Legal Support** One of the primary ways we assist the victims is by providing legal aid. We engage skilled and experienced lawyers to represent the victims in court, ensuring that their rights are protected and their voices are heard. This legal support is crucial in ensuring a fair trial and delivering justice.

Denial of bail and morale scheme In 43 cases, we have faced challenges where victim families had applied for compensation of bail under Manodhairya Yojana, a scheme that provides financial assistance and rehabilitation to victims of sex crimes. Unfortunately, applications for bail have been rejected in these cases. However, in 54 cases, we have successfully obtained support under the Manodhairya Yojana, which has been immensely beneficial for the victims and their families. This support includes financial aid and rehabilitation assistance, which helps the victims to rebuild their lives and cope with the aftermath of the traumatic experiences.

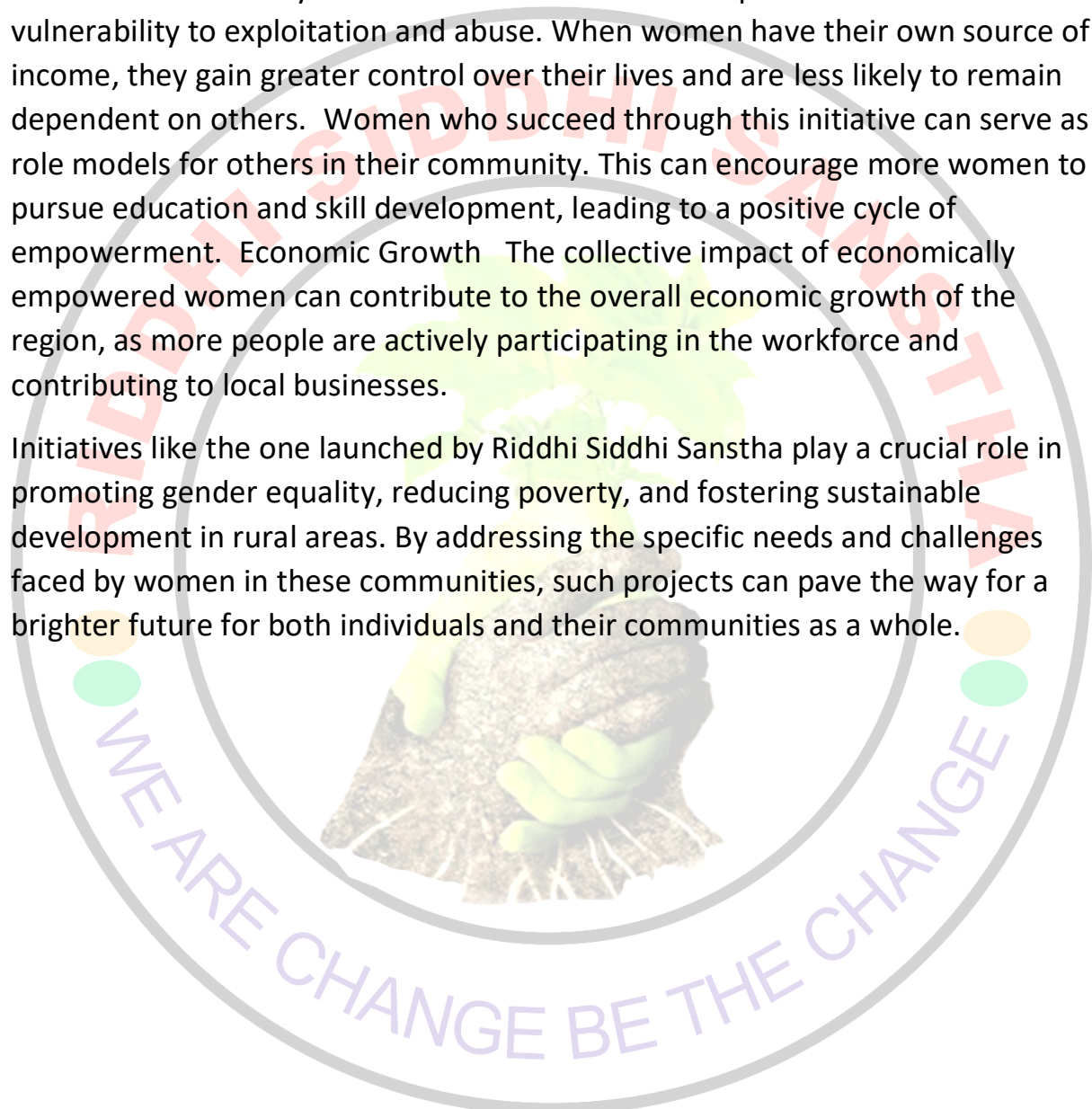

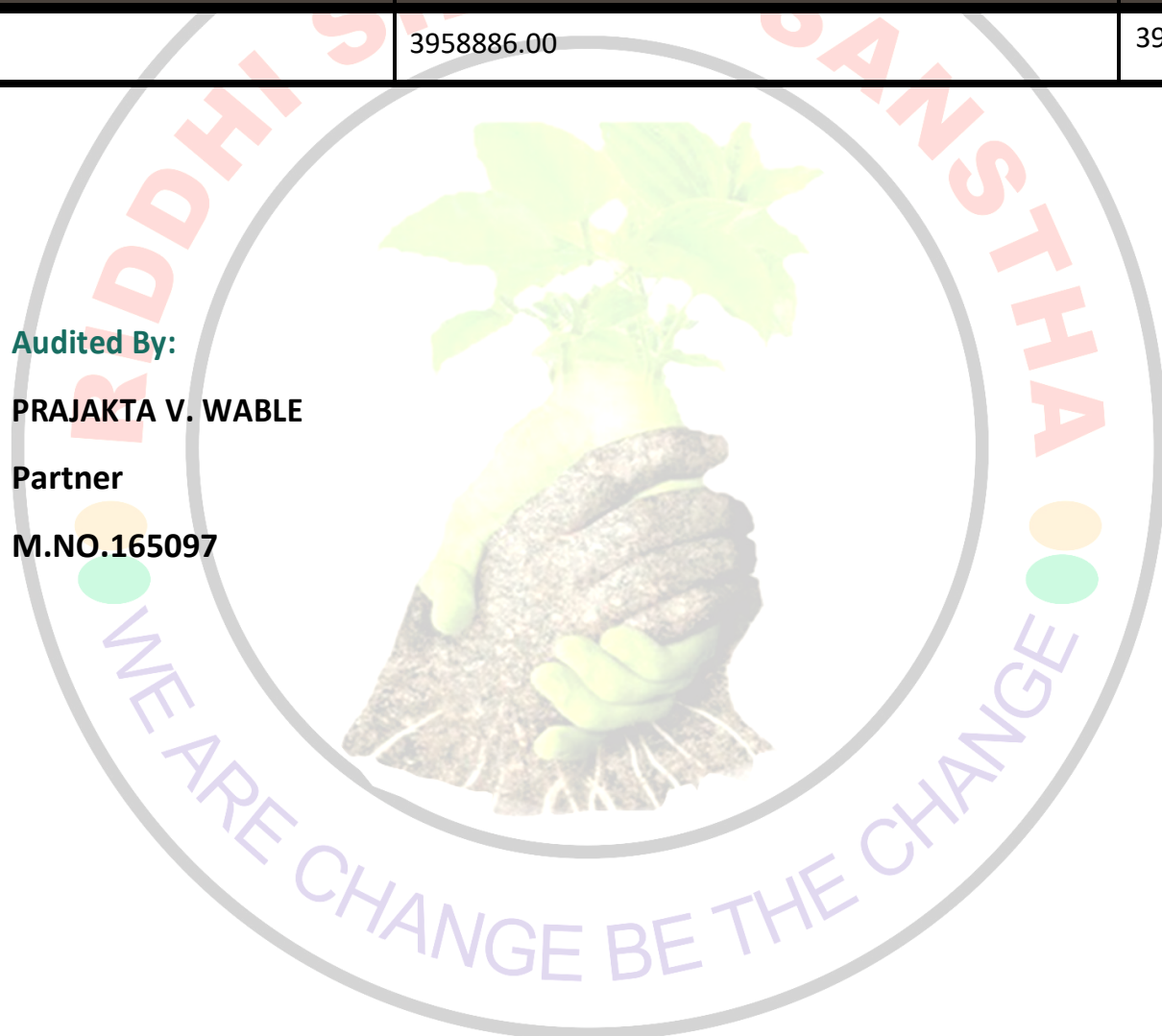

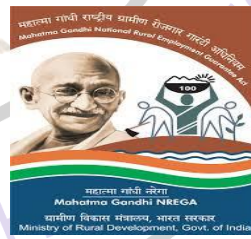


DICLOSURE OF COMPLAINE UNDER POSH ACT,2013
