2022 is a special year for us, as we complete 6 years of our existence. Looking back from where we started, we take great pride in the way we have evolved.

OUR HISTORY:

Riddhi-Siddhi krushi va gramin shaikshanik, samajik sanstha, - Jambulni is a legally registered organization and operational since 2016 in the drought stricken areas of Satara working for prosperity of the poor and marginalized through promotion of knowledge, accomplishment and goal attainment. Its prime objective was agriculture through water and social development by focusing women and young girls. It came into being amidst situation of drought, unemployment, mass migration and acute water problem in the drought prone villages of 'Mann block' of Satara district in Maharashtra. It witnessed situation of mass migration of poor families and pathetic conditions of women and children.

Girls were considered big burden to the family and were married at a very young age to men who later deceived them and left them alone. The sexual offences involving children were rampant namely; rape, molestation, early pregnancy, and incidence of girls missing from the villages clueless about their whereabouts till today.

The Riddhi-Siddhi Institute surveyed more than 100 villages to identify the root cause of the problem of backwardness and poverty in the 'Maan Block'. Severe droughts and agriculture not being the primary source of employment led to unemployment and mass migration. Lack of drinking water added to the burden of women especially girls fetching water from far of villages and became vulnerable to all kinds of mental, physical and sexual abuse. People in the villages are tight-lipped and do not want to do anything with regard to the ongoing issues. Riddhi-Siddhi had gathered courage to address the problem by organizing participation of people, vigilant committees, forming child protection committees, raising awareness in the villages, finding alternatives to the issue of water scarcity, promoting agro-based ventures to prevent mass migration. In the last two-three years it had collaborated with Kailash Satyaarthi Foundation – Delhi and promoted awareness, rescued girls from child marriage, child employment, addressed issues of sexual offences related to girls, formed child vigilantes. So far in the last 06 years it has handled 54 cases of POCSO and 04 cases of human trafficking and commercial sexual exploitation.

The organization was created to bring about change in the society through women empowerment. The creation of 'Stri Adhaar Kendra' a centre for women to promote skills development training to women. The goods produced by them are further sold by the organization and they are starting to get financial income from it and their family is becoming self-sufficient. The organization aims :-

It to make 10 villages economically, socially and politically viable by 2025 and to make maximum number of women sarpanches in priority

I To build an egalitarian rationalist society.

² Creating earning capacity, labor, art skills and intellect from the society.

To develop the neglected weak, deprived, weak, neglected group.

I To build a society without caste, religion, gender, language or region. 5. Enhancing the literacy of the Indian Constitution.

I To promote rights of people.

The overall outcome of the 'Rescue-Project in the coming three years is 'To rescue 150 girls trapped and trafficked into SEC and are needing immediate rescue, support for rehabilitation, reintegration back into the families along with justice done to them in securing proper compensation as per the law and in getting the Offenders punished for the crime.

NEW INITIATIVES

Riddhi-Siddhi through the Rescue -Project' will focus on rescuing 50 girls as direct beneficiaries every year (150 girls in three years) between the age group of 12 years to 19 years, trapped into commercial sexual exploitation. The beneficiaries will be identified based on the information received from girls needing immediate rescue, aftercare services and need access to legal provisional support. The Indirect Beneficiaries would be the Family members and relatives of rescued girls.

Some of the Key risks and vulnerabilities are that the girls to be rescued are from poor background and from the backward region. There are possibilities that they may be re-trapped, may be threatened with dire consequences posing danger to their lives. And there may be a threat to the Rescue Team and their family members. The supporting NGOs may be threatened or stopped from rescue operations. Riddhi-Sidhi Sanstha's rescue team has ample knowledge and experience in rescue and raid operations related to POCSO and commercial sexual exploitation and they have till now 54 cases out of 04 cases related to trafficking of girls. It has strong rapport with Police Department, Shelter Homes, District Administration, Lawyers, Child Welfare Committee, Local leaders, CSR units and other Rescue Forums/Networks and Alliances, etc.

Further inducting survivors into Free-A-Girl India's School for Justice program to pursue higher careers necessary to prevent and uplift girls involved in such crimes in the near future.

The problems resolved will be;

Other girls in the brothel will learn a lesson and gather courage to demand for their rescue.

The rescued girls will overcome problem of hopelessness, helplessness and start living a normal life.

Due to social media the rescue operations will be highlighted and people become aware of such crime and may join collaborative activities in the future. Human trafficking as an issue will come to the surface.

Society at large and those holding responsible position will own the responsibility of rescuing more girls and prevent trafficking.

1. Rescue

Riddhi-Siddhi Sanstha works by undertaking successful raids and rescue operations. Based on accurate information online and offline by investigating victims who need rescue support, preparations and necessary arrangements are made for successful raids. 2. Immediate aftercare support (up to 6 months)

Riddhi-Sidhi Sanstha provided immediate temporary shelter to the survivors, provided them with knowledge and information about rights of child rights and SEC victims, provided them with personal kits to maintain health and hygiene issues and provided support for counseling and medical assistance as needed and helped them with travel and food expenses.

2. Immediate aftercare support (up to 6 months)

Our Riddhi-Siddhi Sanstha provided immediate temporary shelter to the survivors, provided them with knowledge and information about rights of child rights and SEC victims, provided them with personal kits to maintain health and hygiene issues and provided support for counseling and medical assistance as needed and helped them with travel and food expenses.

3. Access to Justice

This will ensure that survivors have access to good lawyers and legal assistance to fight for justice. Ensuring that victims of trafficking receive compensation through the legal system and that perpetrators/offenders/traffickers are punished for the crime. This is the purpose of the organization. Overall Objective:

I To enable SEC victims to rebuild their lives with dignity and respect by creating an enabling environment of support, care and assistance provided by child rights provisions and SEC victims' rights to rescue, then seek care and justice.

Specific objectives:

To rescue 50 girls from forced commercial sexual exploitation (between the age of 12 - 19 years) through investigations and successful raids.

To provide aftercare facilities to 50 girls rescued from SEC such as immediate temporary shelter, knowledge and information on applicable children's rights and the rights of SEC victim as per provisions, health and hygiene care facilities, personal kit, support for counseling, medical support, travel and food expenses, etc.

I To provide access to Justice i.e. assisting them with good lawyers and legal assistance to file suits and to get compensation along with getting conviction to the Perpetrators/ Offenders.

200 people got employment. Riddhi Siddhi Sanstha in Man taluka has provided employment to 200 people through Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in the year 2021-22. MGNREGA is a social welfare program in India aimed at providing guaranteed employment to families in rural areas, thereby increasing livelihood security in rural areas. By providing employment opportunities to 200 people, the organization improved the living conditions of rural workers and strengthened the local economy.

Also, skill development works were done at the village level for the poor Needy women should be trained and made aware of their constitutional rights by improving their economic conditions.

Skill development activities have been undertaken at the village level to benefit the poor and needy women. Empowerment of women through training and improving their economic conditions is

Also, in Satara district, the organization has reduced the number of child marriages to a large extent by implementing Child Marriage Mukt Bharat Abhiyan This is a huge success of the organization. We are proud of it. The organization has worked in three districts of Satara, Solapur, Kolhapur for solid waste sewage management in 11 villages in Satara district, 12 villages in Kolhapur district and 1 village in Solapur district.

INITIATIVE FOR CHILDREN AND ADOLESCENCES

Child Rights Program

Riddhi-Siddhi krushi va gramin shaikshanik samajik sanstha Jambulani is a registered organization committed to the issue of missing girls. And she wants to prevent girls from being trafficked for commercial sex. It is already involved in addressing issues of sexual crimes such as rape, molestation, early pregnancy and cases of missing girls. The overall purpose of the proposed project is to rescue girls who are trafficked into commercial sexual exploitation in districts of Satara, Sangli, Kolhapur, Belgaum, Pune and Mumbai through active participation of the community based organizations, like-minded Civil Society Organization and with the active support of the Law Enforcement Agencies (LEA). Its prime objective is to rescue every year atleast 50 girls trafficked for commercial sexual exploitation and see provide them all the necessary aftercare services such as medical help, counseling and psycho-social support, personal hygiene kit, knowledge of their rights and schemes meant for their development, etc. More importantly to assist the survivors to file legal suits against the traffickers/ offenders to get them punished and also get necessary compensation as per the norms meant for their development. The proposed project will be implemented in three year duration (i.e. from 01st January 2023 to 31st December 2025). The target coverage is to rescue 150 girls (i.e. 50 girls per year) in three years in from brothels and centres close to the places of worship and pilgrimage such as 'Jejuri' in Satara, 'Mahalakshmi' temple in Kolhapur, 'Yelamma temple' in Nipanni and nearby Commercial Business Centres of Satara, Sangli, Kolhapur and Belgaum districts of Maharashtra and Karnataka.

It mainly focuses on 'man-blocks' and drought-affected villages in neighboring districts where girls are trapped and forced into commercial sex. It will also focus on girls trafficked from villages as well as from other Indian states like West Bengal, Karnataka and Andhra Pradesh.The beneficiaries would be identified on the information received from credible sources on girls needing immediate rescue, aftercare and access to legal provision. Riddhi-Siddhi has got a committed and dedicated group of men and women to work as rescue team but will be more involved in cases of commercial sexual exploitation of minor girls. It is eager to learn from the perspective of Free-A-Girl India and get more training in rescue and raids operation. A-Girl is looking forward to learning from India's perspective and getting more training in rescue and raid operations. The issue of commercial sex is a flourishing industry known to be third largest ill-legal business in India and girls are trafficked from all corners of the India and globe. This is a criminal venture because young girls between the age of 12 yrs to 19 years are forcefully trapped to entertain customers for the sake of money. In the past many girls have gone missing from the villages of Satara, Sangli without the knowledge of the concerned local authorities. The practice of 'Devadasi' system of offering girls to goddess 'Yelamma' and to goddess 'Khandoba' popularly known as as Waghya-Muruli has contributed to the sexual exploitation of girls under the garb of religious custom and traditions. The prevalence of sexual exploitation of girls went on without anyone questioning the practice and as social custom. This perpetuated the sexual exploitation of girls and now more girls have entered this trade for want of money or forced by the perpetrators. This is presently going on in the southern part of Maharashtra in the districts of Satara, Sangli (Miraj), Kolhapur and Belgaum (northern Karnataka). The growing challenge is to rescue young girls from this menace against strong religious customs and to deliver justice to girls who do not want to continue with this practice.

Our Riddhi-Siddhi organization works to free girls from forced sexual exploitation through active public participation to stop these crimes through both awareness and action. It is very difficult but still necessary. Therefore, the organization focuses on rescuing 50 girls from commercial sexual exploitation.

Our Riddhi Siddhi Sanstha has done the work of sewage and solid waste management in three districts of Solapur Satara Kolhapur under Swachh Bharat Mission Phase No. 2 along with ZP.The work done by our Riddhi Siddhi Sanstha in sewage and solid waste management is crucial for maintaining cleanliness and hygiene in the districts of Solapur, Satara, and Kolhapur. The Swachh Bharat Mission Stage kr. 2, in collaboration with the Zilla Parishad (ZP), aims to promote sanitation and cleanliness across India.By actively participating in this mission, our organization has to improving the overall quality of life for the residents of these districts. Effective sewage management ensures proper disposal of waste, prevents water pollution, and reduces the risk of diseases. Similarly, efficient solid waste management helps in keeping the environment clean and minimizes the negative impact on human health.

our efforts align with the broader goal of the Swachh Bharat Mission, which is to create a clean and open-defecation-free India. By addressing sewage and solid waste management, is actively working towards achieving this vision. is good work! A solid waste and sewage management survey has been conducted in 11 villages in Satara district and 11 villages in Kolhapur district, similarly a survey has been conducted in Kolegaon in Solapur district. Conducting surveys in 11 villages each in Satara and Kolhapur districts, as well as in Kolegaon village in Solapur district, shows a comprehensive approach to solid waste and sewage management. Surveys are important in assessing the current situation, identifying challenges, and developing effective strategies for waste management. By conducting these surveys, we have gathered important data and insights about the waste management practices and infrastructure in these areas. This information will help in formulating appropriate plans and interventions to address any shortcomings and improve the overall waste management system. It's commendable that our organization is taking a proactive approach by conducting surveys. This demonstrates to understanding the specific needs and challenges of each village and tailoring the waste management solutions accordingly. It also provides a solid foundation for future initiatives and enables you to measure the progress and impact of our work. The survey findings were used to guide efforts to implement sustainable and effective waste management practices in the district.
